Dear Minister

Thank you for your letter of 26th March 2010 on FiReControl. As you acknowledge I think it is important to recognise that the project has proved more challenging and complex to deliver than CLG had anticipated. Sustaining the confidence of both professional officers and FRAs, as you point out, has itself proved difficult. Indeed numerous submissions to the Select Committee are testament to that.

Notwithstanding our previous criticism of the project's management and supplier shortcomings we have remained consistent in our support of the principle behind FiReControl and importantly our view that it amounts to a substantial investment in the Fire and Rescue Service. An investment that now needs to be seen through to a satisfactory conclusion.

As you rightly state both the Association and our members have, and continue to, commit significant time and expertise to the project in order to ensure that what is delivered provides a quality of service that is needed, and demanded, by the public and professional users alike. This extensive support will continue, mindful that the project needs to be driven by both quality and functionality rather than merely to a timeline. Indeed, unrealistic project timescales only seek to undermine confidence in the endeavour.

We have been recommending an independent review of the project for some time and were supportive of the exercise undertaken by Gartner. Given what is at stake, a clear and unequivocal assessment of the project's deliverability was essential. It was also one of the reasons why we called for a credible and worked through contingency plan. As professional officers we regard these as essential elements in managing the substantial risks in this project. Clearly we are reassured by Gartner's assessment and your determination to drive improvement.
