

Take up of council tax freeze grant in 2012-13

As at 8 February 2012 the following 201 authorities have signalled their intention to take part in the Government's 2012-13 council tax freeze initiative by freezing or reducing their council tax.

These figures are for England only and are based on media reports and information from the Internet. They are not based on ratified budgets for 2012-13 or been confirmed with the authority. The official budget decision will be voted on at a Full Council meeting of local authorities in due course.
